Gorgon Project Domestic Gas Expression of Interest

Expressions of interest are sought from potential major customers for the purchase of between 5 and 150 TJ/day of firm deliveries of natural gas from the Gorgon Project's domestic gas plant to be constructed on Barrow Island. The Gorgon Project involves the development of an integrated LNG and domestic gas project on Barrow Island. It is anticipated that in 2015 first domestic gas deliveries will be made available to customers at Compressor Station 1 on the Dampier to Bunbury Natural Gas Pipeline.

Chevron (TAPL) Pty Ltd ("TAPL") is the exclusive Sales Representative for each of the Gorgon domestic gas seller's proportionate share of gas. The Gorgon domestic gas sellers are Chevron Australia Pty Ltd, Chevron (TAPL) Pty Ltd, Mobil Australia Resources Company Pty Ltd and Shell Development (Australia) Pty Ltd ("Domgas Sellers").

To register your expression of interest, please contact Chris Sorensen (for the Sales Representative), who will forward a Confidentiality Agreement to you. Once the Confidentiality Agreement has been executed, you will be sent details of the Gorgon Project, the bid specification and the Gorgon gas sales and purchase agreement (GSA).

The bid specification includes a requirement for bids to conform with the terms and conditions of the GSA, with customers completing a schedule relating to quantity, price and supply period terms. Completed GSAs are to be returned to the Sales Representative as specified in the bid specification.

Bidders will also be required to provide information relating to their financial standing.

Please note that in respect of this letter and the potential sale and purchase of Gorgon domestic gas:

1. The Domgas Sellers reserve the right, without giving reasons, at any time, to revise, supplement or withdraw in any way whatsoever, the terms of this letter and to terminate any related discussions.
2. The Domgas Sellers reserve the right to accept or reject any or all of the expressions of interest received.
3. The Domgas Sellers will not be liable for any costs, expenses or losses incurred by you arising in connection with this letter and the potential gas supply proposal.
4. This letter does not constitute an offer for the sale of gas by any Domgas Seller.
